

PHARMANUTRA S.P.A. LISTED AMONG THE WORLD'S BEST COMPANIES FOR SUSTAINABLE GROWTH BY "TIME" MAGAZINE

The Group was ranked 190th in the 'World's Best Companies - Sustainable Growth 2026' ranking,

which lists the 500 best companies worldwide for exceptional performance in sustainable

development. Out of the 27 Italian companies in the ranking, Pharmanutra ranks thirteenth in the list

compiled by the renowned American weekly magazine Time.

Pisa, 17 November 2025 - A new prestigious standing for PharmaNutra S.p.A. (MTA; Ticker PHN), a

company specialising in mineral-based nutritional supplements and medical devices for muscles and

joints. The Pisa-based group founded by brothers Andrea and Roberto Lacorte is, in fact, one of 27 Italian

companies worldwide included in the "World's Best Companies - Sustainable Growth 2026" ranking

published by the American weekly magazine "Time".

The ranking is the result of a survey carried out by the prestigious magazine "Time" together with Statista,

a company specializing in corporate rankings, which identified the 500 companies that have shown

exceptional performance in sustainable development globally, while maintaining financial stability and

revenue growth.

Among the twenty-seven Italian companies in the ranking, Pharmanutra is in the Top 15 (13th in the

ranking) and, globally, out of 500 selected companies, it is among the top 200 companies in the world

(190th in the ranking), with 83.99 points out of 100. This is a highly significant and proud achievement for

the Group, considering that the ranking includes some of the most important global companies in every

industry.

Andrea Lacorte, Chairman of Pharmanutra, addresses the satisfaction of the entire Group: 'Being part

of the selected group of Italian companies that the renowned and authoritative Time magazine has included in

its special ranking "World's Best Companies-Sustainable Growth 2026" is a very important recognition. This is

mainly for two reasons. Firstly, because the ranking includes the global business elite; therefore, seeing a

relatively young and rapidly growing company such as Pharmanutra alongside names that have made business

history in Italy and worldwide is a source of great satisfaction. Secondly, we are talking about sustainability, a

crucial issue to which we are particularly sensitive, and which will become increasingly important in our

company's development policies. Being ranked among the most sustainable Italian companies in the world is not

only recognition of the work done so far, but also an incentive to continue along this path".











Since 2021, the year of the first Pharmanutra Sustainability Report, awareness of sustainable and responsible development has been integrated into the Group's commitments and strategies. Over the years, the Group has made constant investments in corporate welfare, health and safety, training and inclusion, and initiatives to promote the well-being of its employees. In addition, Pharmanutra has provided support to local communities, launched social and cultural initiatives, and invested in environmental issues. Sustainability for Pharmanutra is thus confirmed not only as a guiding principle, but as a strategic element that involves every area of the company, guiding daily choices and projecting the Group towards a future of ethical, responsible and innovative growth.
